A meeting of the Los Angeles County Board of Education was held on Tuesday, May 14, 2024 at the Los Angeles County Office of Education Board Room.

PRELIMINARY ACTIVITIES

CALL TO ORDER

Dr. Chan called the meeting to order at 3:37 p.m.

Dr. Chan read the LACOE Land Acknowledgement.

PLEDGE OF ALLEGIANCE

Mr. Cross lead the Pledge of Allegiance.

ORDERING OF THE AGENDA

Dr. Duardo indicated that there were no changes to the Board Agenda.

It was **MOVED** by Dr. Johnson, **SECONDED** by Mr. Cross, and **CARRIED** to approve the Board agenda as presented.

APPROVAL OF THE MINUTES -

• May 7, 2024 – The minutes were approved as presented.

COMMUNICATIONS: BOARD / SUPERINTENDENT

Ms. Jimena said AP Testing is almost completed.

Ms. Jocelyn wished all moms a Happy Mother's Day.

Ms. Forrester said that Head Start will turn 59 years old this week and that means 59 years of disrupting poverty, which is such an important issue for the County Board and a goal that all Board Members should be proud of. Ms. Forrester said that she is proud of the work of the Head Start Policy Council and LACOE's support. Ms. Forrester said that we have 94% enrollment in the Head Start program. She said the reason it is not 100% is because of the staffing vacancies, which should be a priority for LACOE. She said that 93 parents and paraprofessionals have completed the Pathways Program this year through the Head Start program and 41 individuals have been hired.

Ms. Forrester also raised a concern about the process used in the County when it comes to student protesting. She said she wants protection against hate, but it should be balanced with protection of the actions of students that act out is alternative form of civil engagement in their own development and critical thinking skills we are teaching them.

Dr. Perez provided an update on the County Policy Committee meeting last week and two important proposals: Unregulated HEP Products that are damaging to kids; Social Media and regulating cell phone use in schools.

Both Dr. Perez and Dr. Chan mentioned the CSBA County Board Member conference in September 2024 and encouraged Board Members to attend.

Mr. Cross asked that the Office of General Counsel to provide a preliminary look at options for new structure, etc. for the voice of the County Board.

Dr. Duardo, Superintendent provided the following highlights to the County Board:

Gain Contract

- The GAIN contract was approved by the Los Angeles County Board of Supervisors.
- With the approval, LACOE was able to send out 89 rescission letters for our LACOE staff.

Pathway Certificate Ceremony - Thursday May 23rd in Board Room 9 AM

- We will be celebrating the culmination of the "Building LACOE Leaders" pathway certificate program on May 23rd
- The program is designed to enhance leadership skills and knowledge for career development and promotional opportunities for LACOE team members.

Community Schools Cohort 3 Implementation Grants

- Los Angeles County has secured the highest number of these grants in California with 222 new awards approved by the State Board of Education on May 8, 2024.
- Over \$290 million is allocated to Los Angeles County schools.

- Six additional CCSPP schools within LACOE's partner districts will receive \$9.2M over the next five years, increasing the number of LACOE implemented community schools to 23.
- Los Angeles County now hosts the largest concentration of community schools in the U.S., aiming to become a national model for school transformation.
- Since 2019, LACOE has been preparing to support 467 grantees with help from the Department of Mental Health and various local partners, ensuring schools become community service hubs.
- Plans to bring updates to the Board, invite visits to CCSPP sites, and discuss future community school transformations.
- Grantees will receive orientation, participate in Communities of Transformational Practices, attend learning visits to other community schools, and receive guidance on engaging families and communities.

Bilingual Teacher Professional Development Program Grant

- The California Department of Education has awarded LACOE Multilingual Academic Support (MAS) Unit a \$3.5 million grant under the Bilingual Teacher Professional Development Program (BTPDP).
- LACOE will lead a consortium that includes the Orange County Department of Education, Santa Clara Office of Education, and Contra Costa County of Education.
- The project will begin in July and will span five years.
- The funding will aid educators in obtaining bilingual authorizations/credentials and developing culturally responsive teaching skills. This includes areas such as biliteracy, dual language programs, world language instruction, and English language acquisition and development across TK-12.
- This initiative builds on the prior \$2.5 million Educator Workforce Investment Grant for Effective Language Acquisition Programs awarded to LACOE MAS by CDE in October 2023.

Visit from Jiangxi Province in China

- Yesterday, our team hosted visitors from Jiangxi Province in China.
- This province in China serves 10 million students from age 3 through university level.
- Our LACOE team and visitors discussed difference in educational systems, how we are supporting students post pandemic and how we are addressing AI in education.

RECOGNITION OF THE 2024 WINNERS OF THE LOS ANGELES COUNTY REGIONAL SPELLING BEE

Mr. Ruben Valles, Chief Academic Officer led the presentation on the Recognition of the Los Angeles County Regional Spelling Bee. Ms. Teri Applebaum, Elementary Program Specialist for CIS and Reading and Language Arts, said that over 200 people attended the Spelling Bee, which took place on March 20, 2024 in Alhambra. Ms. Applebaum showcased a video with highlights of the event. Ms. Applebaum introduced Miss Viviana Chen, student from Walnut Valley Unified School District – Chapparal Middle School who came in Second Place. She also introduced LA County Regional Spelling Bee winner, Mr. Oliver Halkett, 6th Grade student from the Mirman School. Both students addressed the County Board and briefly spoke about their experiences.

The County Board congratulated both students for their academic performance at the Spelling Bee. Dr. Duardo also recognized the parents for their work in supporting their student and helping them to achieve this prestigious recognition.

RECOGNITION OF CLASSIFIED SCHOOL EMPLOYEES WEEK

The County Board and Superintendent recognized May 19-25, 2024 as Classified School Employees Week in Los Angeles County and recognized all Classified Employees in Los Angeles County and throughout California, and also highlighted Classified Staff for all their work and contributions in helping to deliver the crucial programs and services to our districts, schools, LACOE offices, students and their families. Mr. Anthony Radcliff President of CSEA Chapter 624 and Mr. John Parago, SEIU Member, provided brief remarks to the County Board.

Ms. Damita Carey, LACOE Chief Stewart of SEIU-Local 99 was not able to attend.

On behalf of the County Board, Dr. Duardo thanked all Classified Employees for the extraordinary work that they do for our students and schools.

RECOGNITION OF INTERNATIONAL POLYTECHNIC HIGH SCHOOL'S (IPOLY) DISTINGUISHED SCHOOL AWARD

The County Board and Superintendent recognized IPoly High School for their achievement in being recognized as a California Distinguished School by the California Department of Education (CDE). Dr. Chan mentioned that schools are evaluated based on performance and progress on key indicators outlined by the CDE.

Some of the highlights mentioned by Board President Chan included:

- This year, IPoly is one of only 293 middle and high schools across the entire state to achieve this prestigious distinction.
- IPoly has been recognized for its exemplary performance in English Language Arts and Math. Also, the school has shown success in achieving a low student suspension rate and maintaining a high graduation rate.
- This recognition is a testament to the hard work and dedication of our teachers, staff, students, administrators, and the entire IPoly community.

Superintendent Dr. Duardo said she is proud of the IPoly team and that IPoly provides well-rounded standards, project-based education for all students. She said that IPoly teachers and support staff work hard to engage students and support critical thinking and connections to the real world and also thanked the students and families for all that they do. Dr. Duardo recognized Principal Ginger Paul for her leadership and congratulated the IPoly staff for all that they do and for earning the status award of Distinguished School.

LOS ANGELES COUNTY SUPERINTENDENT STUDENT ADVISORY COUNCIL ANIMATION PROJECT SCREENING

Dr. Duardo highlighted the Superintendent's Student Advisory Council Animation Project screening. She said that the 2023-24 Superintendent's Student Advisory Council collaborated with Mr. Lalo Alcaraz, Los Angeles Cartoonist, to produce a short animated film that highlights social justice and equity in Los Angeles County Schools.

Dr. Duardo said that the Superintendent's Student Advisory Council's mission is to amplify student voices, and this project exemplifies that commitment. The students took charge, from selecting the theme to crafting the storyboard, overseeing the editing process, recording the voiceovers and even starring in the animation as themselves. The animated film was presented.

Mr. Lalo Alcaraz addressed the County Board and shared his experience with working with the Superintendent's Student Advisory Council. He said that Dr. Duardo is fortunate to have assembled such an extraordinary group of students. He said that they were amazing to work with and had a rewarding experience.

The County Board thanked Dr. Duardo and congratulated students on a job well done with the short animation film.

Dr. Graswich introduced the AI Task Force Team: Dr. Christopher Hoang, Coordinator II; Ms. Jessica Conkle, CIS Coordinator I; Miss Joy, Student Representative; and Mr. Matt Johnson, Teacher (Physics and AI), at Whitney High School in ABC Unified School District.

The report included the needs assessment analysis and draft guidelines developed in partnership with over 50 representatives from schools, nonprofits, and businesses throughout the Los Angeles County.

A. Adoption of Board Resolution No. 56 to Recognize Lesbian, Gay, Bisexual, Transgender, Queer, Intersex, and Asexual (LGBTQIA+) Pride Month in June 2024

The Superintendent recommends that the County Board adopt Resolution No. 56 as part of the regular County Board meeting on May 21, 2024; and further recommends that the Los Angeles County Board of Education declare June 2024 as LGBTQIA+ Pride Month and that the County Board and Superintendent of Schools hereby advocate for, support, and defend requirements and district-initiated efforts through legislation, policy, and procedure that specifically address the topics of sexual orientation, gender identity, and gender expression as they relate to safe, supportive, and equitable environments; and take such further actions as set forth in the Board Resolution.

Resolution No. 56 is attached.

Next Steps:

- 1. LACOE will join the county, state and federal government in raising the Equity Pride flag in the month of June.
- 2. LACOE is aligning the work of the established LGBTQIA+ steering committee with our broader strategic plan and equity, diversity, and inclusion efforts, aimed at increasing sense of belonging and wellbeing across the organization.
- 3. LACOE is relaunching the Creating an Inclusive Environment for LGBTQIA+ Individuals training for employees in the month of June.
- 4. LACOE will host an Out For Safe Schools professional learning event to celebrate Pride month and to educate and empower LACOE employees.
- 5. LACOE's LGBTQIA+ Steering Committee will create a curated list of books and songs that highlight LGBTQIA+ artists, creators, and experiences and promote inclusion.

BOARD RESOLUTION

NO. 57: 2023-24

LGBTQ Pride Month, June 2024

- WHEREAS 10.3% of California students (UCLA*, 2017) in middle and high school grades identify as Lesbian, Gay, Bisexual, Transgender, Queer, Intersex and Asexual (LGBTQIA+);
- WHEREAS LGBTQIA+ individuals disproportionately experience incidents of victimization, micro-aggressions, unsafe and discriminatory school and work climates, homelessness, family and peer rejection, substance use and suicidal ideation, attempts and deaths by suicide. (*California Healthy Kids Survey*, 2019-2021: *Main Report*. San Francisco: WestEd Health & Human Development Program for the California Department of Education.)
- WHEREAS Visibility, sense of safety and belonging are essential aspects of inclusive and affirming learning and working environments where all students, families and staff see themselves as a part of their school, work and communities;
- WHEREAS LACOE is committed to ensuring that schools are safe and affirming spaces for all students, staff and families and to fostering a safe, respectful and inclusive community culture;
- WHEREAS California state law prohibits discrimination, harassment, intimidation and bullying towards LGBTQIA+ students and staff;
- WHEREAS LACOE denounces prejudice and discrimination based on age, race, color, religion, marital status, national origin, actual or perceived disability, actual or perceived sexual orientation, gender identity and/or gender expression as an affront to our fundamental principles;
- WHEREAS LGBTQIA+ inclusive curricula and content highlights the importance of honoring and affirming diverse and intersecting identities and the contributions of the LGBTQIA+ community throughout history;
- WHEREAS In 2019, State Superintendent of Public Instruction Tony Thurmond and the Equality California Institute co-sponsored Assembly Bill (AB) 493, known as the Safe and Supportive Schools Act, which encourages teachers to receive training on school and community resources available to support LGBTQ+ students facing bullying, harassment, discrimination, or lack of acceptance at home or school.
- WHEREAS In 2023, the California Department of Education has contracted with LACOE along with lead partner agency the Equality California Institute and an advisory committee composed of 20 nonprofit organizations, including the Trevor Project and the Human Rights Campaign Foundation, to develop the project called

PRISM (Providing Relevant, Inclusive Support That Matters for LGBTQ+Students).

WHEREAS

The PRISM project will, by June of 2025, develop training on topics such as: 1.) Identifying LGBTQ+ youth who are subject to, or may be at risk of, bullying and lack of acceptance at home or in their communities; 2.) Identifying local, community-based organizations that provide support to LGBTQ+ youth; 3.) Providing information regarding school antibullying and harassment policies and complaint procedures; and 4.) Identifying local physical and mental health providers with experience in treating and supporting LGBTQ+ youth and forming peer support or affinity clubs and organizations.

WHEREAS

An LGBTQ+-inclusive education benefits the health and well-being of all students, and the PRISM project fosters acceptance and promotes positive learning and working environments for LGBTQ+ students.

WHEREAS

An LGBTQIA+ inclusive education benefits the health and wellbeing of all students and empowering education and curricula seek to actively disrupt and challenge a dominant, single narrative, eliminate hate, bias and related harmful impacts on wellbeing of all individuals in our schools and communities;

WHEREAS

All schools must do more to ensure that LGBTQIA+ staff and students have the necessary support and resources to live as our authentic selves with unconditional value, without criminalization, discrimination and/or stigma; and

WHEREAS

- NOW THEREFORE BE IT FURTHER RESOLVED, that the Los Angeles County Board of Education and the County Superintendent of Schools will continue to establish and/or strengthen partnerships with LGBTQIA+ focused community-based and non-profit organizations and institutions of higher education to gain evidence-based resources, instructional materials and high-quality professional learning.
- NOW THEREFORE BE IT FURTHER RESOLVED, that the Los Angeles County Board of Education and the County Superintendent of Schools will continue to support the work of the LGBTQIA+ steering committee, established in 2022 to facilitate ongoing review of, discussions about and advocacy for elevating the needs of LGBTQIA+ staff, students and families, advancing equity and inclusion for

BOARD RESOLUTION No. 57: 2024-2025

Immigrant Heritage Month (June 2024)

WHEREAS,

In 2019, the United States Congress acknowledged the month of June as "Immigrant Heritage Month". This recognition is a celebration of the numerous contributions and accomplishments that immigrants and their children have made in shaping the history, economy, and culture of the United States. Immigrants and their children have played pivotal and influential roles in the development of American culture and art, just as they have in science and academic institutions. Their presence has helped bring about increased openness and acceptance in American institutions toward diverse perspectives and ideas. This acknowledgment serves as a reminder of the positive impact of immigration in the United States and the need to celebrate the diversity and contributions of immigrants.

WHEREAS,

On June 20th every year, we commemorate World Refugee Day to celebrate the resilience and bravery demonstrated by refugees from all corners of the world. This day also marks the signing of the 1951 Convention Relating to the Status of Refugees by the United Nations, which highlights the importance of safeguarding the rights of this vulnerable group. Refugees and immigrants possess an unwavering fortitude and tenacity that often leaves people in awe when they hear their stories of survival and determination. However, their struggles do not end once they reach our shores, as they often encounter numerous obstacles such as linguistic barriers, difficulty navigating unfamiliar cultural norms, providing education to their children, finding employment, accessing housing, transportation, and essential services.

WHEREAS,

On June 15, 1982, the Supreme Court of the United States made a landmark decision in Plyler v. Doe that had a significant impact on the lives of countless immigrant children in the country. The ruling stated that every child living in the U.S. should have the opportunity to live a full life and engage meaningfully in our society and economy, regardless of their immigration status or that of their parents. This meant that all children, regardless of their background and legal status, were entitled to access K-12 public education and the benefits that come with it.

WHEREAS,

Los Angeles County has a long-standing history of welcoming and hosting newcomers from various parts of the world. Among the most recent arrivals are refugees and asylum-seekers from Afghanistan, Syria, Guatemala, Iraq, Ukraine, and other countries where people are facing persecution and violence. Despite the challenges of resettlement, Los Angeles County has remained committed to providing a safe and hospitable environment for these newcomers. The county has set up various programs and services to support their integration into the community, including language courses, job training, school enrollment information, legal services, case management, counseling services, and more.

WHEREAS, According to the Vera Institute Of Justice, studies show that 4.4 million immigrants reside in the Los Angeles Metro area; 2.2 million non-citizens in the LA Metro area are potentially at risk of deportation; there are 1.6 million children in the LA Metro area with at least one immigrant parent; five in nine children with at least one immigrant parent; the vast majority of children with at least one immigrant parent in the LA Metro area are U.S. citizens.

WHEREAS, LACOE is dedicated to ensuring that every child is welcomed with dignity into our communities and the organizations that serve them. To achieve this goal, LACOE offers a wide range of professional development opportunities to educators, administrators, and other school district personnel. LACOE recognizes the importance of community engagement and meaningful partnerships in creating welcoming and inclusive schools. That is why LACOE continuously works closely LEAs, community organizations, and other stakeholders to ensure that every child has the support they need to succeed

WHEREAS, LACOE has been providing support to school districts in the region with instructional programs aimed at improving the English language development (ELD) of students. This program aims to enhance children's linguistic capabilities and promote social-emotional learning (SEL) to increase emotional competencies. Furthermore, LACOE's Immigrant Relations program continues to assist Los Angeles County School districts, parents, and students with timely information and resources related to immigration policies.

WHEREAS, LACOE has a strong commitment to safeguarding the constitutional right of every child to receive a free public education, irrespective of their immigration status, and strives to remove any obstacles that may hinder enrollment. LACOE's Immigrant Relations program works towards promoting school district compliance to ensure that all children, regardless of their immigration status, have equal access to education and resources.

WHEREAS, LACOE is committed to providing a safe and welcoming learning environment for immigrant and refugee students. Through a range of programs such as the Immigrant Relations Program, Multilingual Academic Support Unit, CalNEW, Wellbeing and Support Services, and Migrant Education, LACOE ensures that these students have access to the resources and support they need to enroll in school, feel safe and supported, and be healthy and engaged in their education. LACOE also facilitates the navigation of services for immigrant communities in LA County by creating meaningful connections between school districts and other stakeholders in the community. This ensures that immigrant students and their families have access to essential services such as legal support, healthcare, and education assistance.

- WHEREAS, LACOE's Immigrant Relations program ensures that districts, students, caregivers and communities are empowered with culturally and linguistically relevant resources and promotes school compliance to policies that protect students and their families.
