Dr. Chan thanked Dr. Duardo and staff for a great Board Retreat last week. She also mentioned she will continue to be the Board Liaison with the LACSTA group and that one of their goals is to increase membership with all of the 80 school districts.

Dr. Chan provided an update on the CSBA Transition Group.

Ms. Forrester made the following statement: "It's just that we still have no pathway to peace for children and families in the Middle East, and I believe that this Board can and should take a stand to end the attacks on children in their communities and send in humanitarian aid as soon as possible."

Dr. Montaño made the following statement: "As our numbers reach 11,000 children dead in the Middle East, and the uprising in polio, my heart goes out to the children there, and I have to echo Betty's concern and comments."

Dr. Perez said that LA Mission College is having their 50th year celebration on Thursday and he will be there to represent the County Board. He said he would provide an update in the future about the event.

Equity Leads Statewide

- LACOE's Division of Equity, Diversity, and Inclusion, under the leadership of Dr. Jamaal Williams, has received an Intent to Award Notification from the CDE to serve as one of three Equity Leads statewide.
- Year one of this grant is \$1.5 million, with a total of \$6.25 million over five years.
- As an equity lead, LACOE will partner with the two other awardees/COEs (Kern and Sonoma) to support local educational agencies (LEAs) statewide to identify barriers and opportunities and implement actions and services to meet the identified needs of all pupils, including by addressing racial disparities in opportunities and academic outcomes.
- Additionally, Equity Leads will identify existing resources (including support for educator preparation, recruitment, retention, and professional development) and monitor the impact of the implementation of local control and accountability plan goals. Equity Leads will prioritize support to schools receiving Equity Multiplier Funding.
- We are also pleased to share that the CDE has recognized LACOE's "Supporting the African American Learner" publication as a framework to guide this statewide effort.


