Bid opening and public reading will consist of LACOE clicking to open the submitted bids in front of any interested members of the public and staff in a public setting, whether in-person or virtually online, on November 7, 2023 at 3:00 p.m. Bids received after the deadline will not be considered. Bidders who wish to attend the in-person bid opening must check in check-in with the receptionist for the meeting room location. Attendees must comply with all official orders, CDC and LACOE guidelines and practices relating to COVID-19.

No bidder may withdraw his bid for a period of 90 days after the date set for opening of bids. LACOE reserves the right to reject all bids.
