The Office of Special Education and Rehabilitative Services and the Office of Elementary and Secondary Education released both a Dear Colleague letter and guidance on Building and Sustaining Inclusive Education Practices. The documents emphasize the importance of inclusive educational practices that align with the Elementary and Secondary Education Act of 1965 (ESEA) and the Individuals with Disabilities Education Act (IDEA). These practices benefit students with and without disabilities, ensuring that each child can engage in the curriculum and have access to various supports, electives, and extracurricular programs offered in school.
