CDE RIGHTFUL PRESENCE LETTER

The CDE has released a letter (Link) on Rightful Presence and Inclusive Early Education Programs as the First Consideration for Children with Disabilities.

Including students with disabilities in preschool programs can be important as an early intervention strategy.

AB 2085: <u>LINK</u>

AB 2085 brings significant changes to how child neglect is defined which affects reporting. As teachers are mandated reporters, these changes are very important.

Educators made 24% of reports, but only 6.5% were found to be substantiated after investigation. Assembly Bill 2085 is designed to help by revising the definition of general neglect under the Child Abuse and Neglect Reporting Act (CANRA) in CA.

PROPOSED BILL: AB 560: LINK

Dawn Addis, Assemblymember, 30th District has introduced legislation that significantly affects special education caseloads. This bill would reduce resource specialist caseloads from a maximum of 28 students to 20 students, which includes initial assessments. Proposed caseload changes also affect speech and language specialists, adapted physical education psychological services and more.

The bill also would require schools to create Special Education teams to focus on inclusive practices.
